CDD Board of Supervisors Vacancy Announcement

The Brandy Creek Community Development District Board of Supervisors is seeking candidates for consideration for appointment to fill the vacancy of CDD Board Seat 1 for the remainder of the term of office that expires in November 2026.

Candidates must be registered voters residing in Brandy Creek (Johns Creek community – Phase I and Phase II). Persons interested in being considered to fill the vacancy should submit via email a letter of interest or resume to the District's Recording Secretary Sarah Sweeting (<u>ssweeting@gmsnf.com</u>) no later than noon on February 21, 2023.

The Board of Supervisors will review resumes and will make a selection by majority vote at the next CDD meeting to be held on March 1, 2023. Candidates are encouraged to attend the meeting to introduce themselves to the Board. The candidate elected by the Board to fill the vacancy will be sworn into office immediately to participate in the meeting, if available.

Community Development Districts are governmental entities and supervisors are public officials subject to the Florida Sunshine Amendment and Code of Ethics. Within 30 days of appointment, the new supervisor will be required to file a Statement of Financial Disclosure (Form 1) with the St. Johns County Supervisor of Elections. To view the form please visit <u>http://www.ethics.state.fl.us/</u> (the form is required after appointment, not as part of the application process). For more information regarding the duties and responsibilities of the Board of Supervisors, please consult Chapter 190, Florida Statutes.

CDD vs. POA – What's the difference?

Johns Creek, like so many neighborhoods in Florida, has both a CDD (Community Development District) and a POA (Property Owners Association). Who should be contacted about changing a house color? Who is responsible for the pools? Hopefully, this will help clarify the difference:

A POA governs the community to make sure the community remains fiscally healthy, that the homes within the community are adhering to the deed restrictions. They have their own budget, board of directors, and property manager (company) separate from the CDD. Within Johns Creek, we have both a POA for phase 1 and a POA for phase 2. These POA boards oversee several committees such as Social Committee, Neighborhood Watch Committee, and the Architectural Review Board. POA dues are paid annually, directly to the management company representing your POA.

The CDD is a governmental entity originally set up by the developer. Through medium-tolong-term municipal bonds, it serves the community by planning, financing and building, operating and maintaining specific infrastructures and amenities for residents. For instance, those funds may be used to put in water, sewer, electrical infrastructures, pools, tennis courts, clubhouses, common area landscaping, and pool maintenance, among others. The CDD also has an elected Board of Directors responsible for their own budget, management organization, common areas and amenities. CDD fees are paid as a non-ad-valorem tax that is included in your annual tax bill.

Recipe of the Month

Valentíne Pretzel Bítes

Ingredients

Equipment

- 15-inch Parchment Triangles
- Cake Boards
- Baking Sheet

Ingredients

- 2 bags light Cocoa Candy Melts Candy (12 oz.)
- 48 Mini Pretzel Twists
- 1 bag White Candy Melts Candy (12 oz.)
- Jumbo Heart Sprinkles
- Valentine Nonpareils Sprinkles

Dírections



Melt Candy Melts

- In a medium bowl melt two bags of light Cocoa Candy Melts according to package directions.
- Pour melted candy into the cookie pan. Tap pan to spread candy evenly. Line up and slightly press pretzels into the melted candy, mixing six rows of eight pretzels.

Make Hearts

- In a medium bowl, melt 6 oz. White Candy Melts according to package directions.
- Place melted candy into a parchment bag. Cut a small hole in the tip of the bag. Pipe white candy inside the pretzel to form a heart shape.
- Immediately topo each pretzel with one Jumbo Heart Sprinkle in the center of the heart, pushing down slightly to set. Continue until all pretzels are filled. Chill until set, 30 to 35 minutes.

Unmold Candy

• Transfer sheet of dipped pretzels onto a cake board and let come to room temperature. Using a knife, cut candy into squares.
